- Event Planner Website Active

     This is the person that will receive the monthly newsletters with updates as well as the person who will be managing invitations and ticket distribution.
- Payment Deadline: March 29

#### May

- Corporate Kick-Off Event: May 6
  - This event will be an opportunity for you to engage with our staff and ask questions regarding your hospitality experience.

#### June

- Create Guest Lists
  - Begin compiling a list of guests you would like to invite. Make sure to have a secondary list in case someone cannot attend.
  - Send out Save the Dates to make your guests aware of the tournament.
- Corporate ID Form Due: June 7
  - $\circ\quad$  This form will indicate how your company name will be represented on signage.
- Corporate Patron Virtual Workshop: June 11-13
  - The workshops will allow for our staff to walkthrough a presentation which will go over all hospitality logistics.
- Final Merchandise Order: June 21
  - This is the final deadline to submit your order for corporate merchandise.
- Ticket Distribution: June TBD
  - Tickets will be available to you in June. The ticketing process will be electronic and we will have a step-bystep guide to help you through the distribution process.

#### July

- · Begin sending formal invitations to guests: First or Second Week of July
  - This is a good time to begin inviting your guests to give them time to plan as well as provide you with enough time to follow up with RSVPs and invite another round of guests if needed.
- Official Program Ads due: July 3
  - o If you have a program ad included in your package, they will need to be submitted and approved by July 3.
- Ticket Management Webinars: July 17 & 18
  - We will host webinars to walk you through the ticket management platform. We encourage you to attend
    one of these sessions as we will answer any questions you have regarding the ticket distribution process.
- RSVP deadline: July 26
  - Our suggestion is to set the RSVP deadline for this date. This allows you for enough time to follow up with guests that have not responded prior to tickets becoming available.
- · Distribute tickets to guests: Week of July 29
  - We suggest beginning this process the last week of July. This will provide you with enough time to troubleshoot any issues your guests may have.

### August

- Shipments accepted: August 1-18
  - If you are planning to ship anything to the BMW Championship, we must receive the shipment prior to the start of championship week.
- Venue Walkthrough Forms: August 5
  - Venue walkthroughs are available to anyone who would like to tour Castle Pines Golf Club and your venue prior to the start of Championship Week. You must complete and submit the sign-up form by August 5.
